The application for benefits for education and participation takes place with the submission of the main application. It is necessary to submit attachments / evidence for the desired service in good time (before the payment is due).

Separate attachments / evidence for each type of benefit are required for each child.

The services are in each Responsibility processed and decided. Billing takes place directly with the Provider of the service or with the applicant. You must keep receipts, invoices, evidence and registrations.

Other services (e.g. youth welfare or Training allowance) have priority and exclude services from the education and participation package.

Who is eligible?

As a recipient of benefits of

basic security benefits
(formerly citizen money, SGB II),

Housing benefit or child allowance
(the WoGG),

Social care
(the SGB XII)

or

benefits from the AsylbLG
(Asylum Seekers Benefits Act)

you are eligible.

For whom can benefits be requested?

Benefits can be for children, adolescents
and young adults under the age of 25
(or under 18 years of age for "participation in
social and cultural life") who attend a general or
vocational school or day care center / day care center.

This does not apply to students
who receive a training allowance.

What services are there?



Lunch
in the school / after-school
care center or in the day care facility



Reimbursement
of costs for day trips and class trips for
school and day care facilities / child day care



School materials / school supplies
by August 1st. and on 01.02. every year



Learning support and tutoring



Allowance for extracurricular activities,
e.g. in sports, culture and socializing, art and
music lessons or comparable activities in the amount
of 15.00 € per month up to the age of 18



School transport costs

Note: The costs must be applied for in advance
from the Office for Education, Department of
School Education, of the Landkreis Börde.
